CLIENT FACES ADVERSE DIAGNOSIS

Adverse prenatal diagnosis ... these three words do not crop up very often in the vocabulary of the general public except by those involved in the medical profession. The phrase refers to conditions affecting the unborn child that can cause severe abnormalities or death in utero, at birth, or shortly after. Trisomy, where an extra copy of a chromosome is present, and anencephaly, a condition where part or all of the cerebral hemispheres are absent, are two such frightening examples.

For the first time in our local Birthright history, according to the memories of our longest serving volunteers, a client received the devastating news of an adverse diagnosis after an ultrasound during her second trimester. Her baby had something seriously wrong which was "incompatible with life." The doctors recommended that Elena, the young mother, terminate the pregnancy immediately.

Just when these tragic events were occurring, Elena's client advocate at Birthright, Lori, was doing her regular follow-up calls as required of all volunteers to insure our expectant mothers are doing well and not in need of any help at the time. After reaching Elena and learning of her client's

tragic diagnosis, Lori knew she needed to consult with our director immediately for prayers, advice and available alternatives.

Director Lily contacted Elena who shared the news that she and

her husband had already made the decision to abort the baby. She did graciously listen to Lily who spoke with her at length and urged the client to let God work through her

Our sincere gratitude goes out to these generous groups, as well as to many other private donors who bring baby clothes.

But most of all, our sincerest gratitude goes to individual donors, church groups, and civic organizations who donate funds, sometimes on a monthly basis, to support our worthy cause. They are our primary resource for funding to keep our organization and its worthy mission running. Without them the road ahead would be very difficult.

In my short tenure as director, I was privileged in December to assist with a client's heartrending case when she received the tragic news of her baby's adverse diagnosis. I was a personal witness of the team work of our great volunteer force which came together to assist and provide the love and support to this special client until the very end of her pregnancy. according to His will. The young mother agreed to consider her words and to reopen the discussion with her husband. Lily promised to meet her for lunch the next day.

Things were happening very fast and the young couple increasingly felt the pressure from the medical community who advised an abortion because of possible bad effects on the mother's health, they said, as well as hinting that she might not be able to have more children if she didn't terminate.

But God was working even faster, as it turned out. We at Birthright were all on high alert and praying fervently for a good outcome. We also were soon reminded that there are no real coincidences in life. Another active Birthright volunteer, Donna F., alerted us that she had a neighbor who could speak eloquently from experience because she too had received an adverse prenatal diagnosis.

Paula Stryker and her husband Richard of Spotsylvania, the parents of three, had received in 2011 the tragic news from an ultrasound at twenty weeks gestation that their baby had heart and brain abnormalities that would not allow her to survive. In a recent continuing education program for Birthright volunteers, Paula related how she felt upon hearing the results: "It was the hardest day of my life."

Elaborating during her presentation, Paula explained that, as people of faith with a strong belief in the sanctity of life, the Strykers knew they were going to support their daughter. Paula promised God that she would carry her as long as He wanted. Corrine Catherine Stryker was born on December 17, 2011, and lived a little under two hours.

Who better to console and counsel our young Birthright mother in so much distress? Paula was Heaven-sent and an invaluable counselor. With the promised support and prayers of so many, as well as those of their own families, Elena and her husband decided against terminating the pregnancy and to leave everything in God's hands.

Baby Faith Aracely arrived on December 15, 2014, about 2 PM. In addition to her parents, this little angel from Heaven was welcomed by a multi-generational family group that included a great grandmother, grandparents, her siblings, cousins, and close friends before going back to God about midnight.

Paula Stryker is the founder and director of Embracing Grace, a ministry that offers peer support and a network of resources for women

and families who receive a life-limiting diagnosis and who choose to carry their child to term. The group is made up of fourteen families who receive support from the Catholic Diocese of Richmond as well as from St. Patrick Church of Spotsylvania, part of the Diocese of Arlington.
